**MEMBERS' AGREEMENT  
REGARDING THE USE OF ALL SERVICES AND AMENITIES AT  
WARFIELD EQUESTRIAN PARK (WEP)**

1. Warfield Equestrian Park is available for riding and instruction purposes to **REGISTERED MEMBERS ONLY. NO EXCEPTIONS.** FINES strictly enforced. Users must sign in upon each visit to the premises.
2. All members must wear approved safety equipment as required by the USEA rules. Required safety equipment includes an ASTM approved helmet with fixed harness and smooth-soled boots with heels. Sneakers are not allowed unless specifically designed for riding. A safety vest is strongly recommended for all riders jumping cross-country. Reckless or out-of-control riding is prohibited.
3. Park in designated areas only, on west edge of property and please remove your garbage.
4. No unauthorized motor vehicles allowed in riding areas. Motorized vehicles may be used for purposes of construction, maintenance, and administration of equine activities.
5. No loose horses. The arena is not to be used as a holding pen for loose horses.
6. **Dogs allowed on leash ONLY.** No loose dogs. FINES will be strictly enforced.
7. Cross-country riders must be accompanied.
8. Adult supervision required for children under the age of 18.
9. The main gate must be kept locked when not in use. Please lock gate when you leave.
10. **Instructors must be members** and proof of insurance for instructors must be submitted to WEP prior to conducting lessons on the WEP property. An instructor is defined as anyone who accepts remuneration for giving instruction in any form of equitation (whether Western or English) or horse training on or off of WEP property. 11. No firearms allowed.
12. No unauthorized open fires.
13. Violation of any portion of this agreement may result in forfeiture of member access to WEP or automatic dismissal from an organized event at WEP.

**I, the undersigned, have read the above rules of this agreement for Warfield Equestrian Park and do agree to abide by these rules.** I realize that horseback riding is a high-risk sport and I am participating at my own risk. I hereby release and hold harmless WEP, WECC, Inc., its officers and members from all liability for accidents, damage, injury, theft or illness to horses, owners, riders, employees, attendants, spectators or any other person or property suffered while riding at Warfield Equestrian Park for schooling, recreation or competition purposes. Montana State Law protects equine operators, trainers, promoters and others from liability from injuries or damages that are the result of an equine animal's behavior. (Equine Liability Act, MT SB 0140; Equine Activity Statute, MCA § 27-1-725, 1993.)
