MEMBERSHIP AGREEMENT  
REGARDING THE USE OF WARFIELD EQUESTRIAN PARK

1. Warfield Equestrian Park is available for riding and instruction purposes to active MEMBERS ONLY. NO EXCEPTIONS.
2. All members must wear approved safety equipment as required by the USEA rules. Required safety equipment includes an ASTM approved helmet with fixed harness and smooth-soled boots with heels. Sneakers are not allowed unless specifically designed for riding. A safety vest is strongly recommended for all riders jumping cross-country. Reckless or out-of-control riding is prohibited.
3. For the sake of the Park and convenience of everyone, please:
  - Park in designated areas only, on west edge of property.
  - Take your garbage out with you.
  - Don't drive on the cross country course.
  - Keep your dogs on a leash.
  - Use the arena and the round pen for riding/training purposes, not as a turnout pen.
  - Lock the gate when you leave.
  - Enjoy the stables, but strip your stall when you leave. Stays of more than 48 hours require advance permission.
4. Cross-country riders must be accompanied.
5. Adult supervision required for children under the age of 18.
6. Unless the Park has been reserved for an organized event or activity (forms available on [www.warfieldpark.org](http://www.warfieldpark.org) ), instructors must be members and must provide proof of insurance prior to conducting lessons at the Park. All persons riding with an instructor must also be members. An instructor is defined as anyone who accepts remuneration for giving instruction in any form of equitation (whether Western or English) or horse training.
7. No firearms or open fires allowed.
8. With advance permission, members may use jump equipment from storage. During active riding season, the Board intends to leave limited jump equipment in the arena for members to use.

Violation of any portion of this Membership Agreement may result in forfeiture of access to Warfield Equestrian Park and/or dismissal or exclusion from organized events and activities held at the Park.

I have read the above rules and do agree to abide by these rules. I realize that horseback riding is a high-risk sport and I am participating at my own risk. I hereby release and hold harmless Warfield Equestrian Community Center, Inc. and its officers and members from all liability for accidents, damage, injury, theft or illness to horses, owners, riders, employees, attendants, spectators or any other person or property suffered while riding at Warfield Equestrian Park for schooling, recreation or competition purposes. Montana State Law protects equine operators, trainers, promoters and others from liability from injuries or damages that are the result of an equine animal's behavior. (Equine Liability Act, MT SB 0140; Equine Activity Statute, MCA § 27-1-725, 1993.)
